HEALTH CARE:HELPS INTERNATIONAL'S HEALTH CARE PROGRAM IS WORKING TO FILL THE GAPS IN HEALTH CARE AND BRING HOPE TO RURAL AREAS OF GUATEMALA. WITH A NETWORK OF U.S.-BASED VOLUNTEER MEDICAL TEAMS, HELPS IS PROVIDING PREVENTIVE CARE, SURGERY AND COMMUNITY EDUCATION TO UNDERSERVED COMMUNITIES. EACH TEAM IS MADE UP OF 65-100 VOLUNTEERS THAT INCLUDE SEVERAL DOZEN PHYSICIANS, NURSES, INTERPRETERS, DENTISTS, TECHNICIANS AND SUPPORT STAFF WHO TRAVEL WITH US TO REMOTE AREAS WITH SEVERELY LIMITED ACCESS TO HEALTH CARE. THESE MEDICAL TEAMS ARE FULL SERVICE INCLUDING CLINICS, PLASTIC SURGERY, GENERAL SURGERY, OPHTHALMOLOGY, DENTAL, AND RADIOLOGY. HELPS TEAMS HAVE PROVIDED CARE TO MORE THAN 275,000 PATIENTS SINCE 1994. IN 2016, 10,664 PATIENTS WERE ASSISTED BY 10 HELPS TEAMS.

HELPS INTERNATIONAL'S COMMUNITY DEVELOPMENT PROGRAM IS DRAMATICALLY IMPROVING HEALTH AND SAFETY IN RURAL HOMES BY INSTALLING FUEL-EFFICIENT COOK STOVES, WATER FILTERS, AND OTHER HOUSEHOLD PRODUCTS. THE OPEN FIRES TRADITIONALLY USED FOR COOKING INSIDE HOMES LEAD TO DEVASTATING RESPIRATORY PROBLEMS AND SEVERE BURNS. IN ADDITION, WATERBORNE DISEASE IS A SIGNIFICANT PROBLEM IN GUATEMALA, WHERE MILLIONS OF PEOPLE LACK ACCESS TO CLEAN DRINKING WATER. EACH YEAR, MORE THAN 165 STUDENTS FROM EARLY CHILDHOOD THROUGH 6TH GRADE RECEIVE A QUALITY EDUCATION AT THE HELPS SCHOOL. IN ADDITION TO PRE-K-6 INSTRUCTION, HELPS OFFERS EXTRACURRICULAR ENRICHMENT ACTIVITIES, EXCEPTIONAL TEACHER TRAINING AND STUDENT SCHOLARSHIPS FOR SECONDARY SCHOOLS.
